Cooperation with China in higher education and research

On January 19, <u>NOS published an article</u> about the Cross Cultural Human Rights Centre (CCHRC), affiliated to the Vrije Universiteit (VU), revealing that the center receives its entire budget from the Chinese Southwest University of Political Science and Law in Chongqing. The article also refers to statements on the CCHRC website that contradict the findings of human rights The matter sparked a renewed debate on China's influence on Dutch higher education and research. The LeidenAsiaCentre already published <u>various</u> <u>reports</u> on this topic in previous years. <u>In October 2020</u>, Ingrid d'Hooghe and Jonas Lammertink developed various recommendations for ensuring sustainable cooperation with China that is one the one hand fruitful for both sides, and on the other hand guarantees that academic values, human rights, and the safety of people around the world are not undermined. <u>Earlier that year</u>, d'Hooghe and Brigitte Dekker published a Clingendael report on Chinese political influence in the Dutch higher education system.

Now that the topic of academic collaboration with China is again at the centre of attention, various LAC researchers have written about or commented on the recent developments:



LAC Shorts: "China-MENA relations in the Renewable Energy Sector"

LAC shorts are articles written by or interviews conducted with LeidenAsiaCentre researchers on important developments in Asia.

A few weeks ago, <u>Dr. Mohammadbagher Forough</u> wrote a <u>LAC report</u> on China - Middle East and North Africa (MENA) relations in the renewable energy sector. In the report, Forough focuses on specific cases of Chinese cooperation with Saudi Arabia, the United Arab Emirates (UAE), Iran, Turkey, and countries in North Africa (particularly Egypt and Morocco), in order to unpack China's



diplomatic and economic interactions with the rest of the world and what does this mean for BRI project around the globe?

Secondly, in June US President Biden announced his BRI-alternative 'Build Back Better World', while the European Commission President von der Leyen has announced the 'EU Global Gateway' – Europe's new connectivity plan. How do the US and EU envision competing with the BRI? And what are the consequences for China's grand initiative?

In 2020, President Xi Jinping announced that China aims to hit the peak of its CO2 emissions before 2030, committing to net-zero emissions before 2060. In the coming decade carbon emissions will therefore continue to rise. At the same time, the country invests in renewable green energy, has committed itself to support no more new coal-fired power projects abroad, and tries to increase the environmental sustainability of the BRI with the Belt and Road Initiative
